# **Client Case Study - Unispace**





Unispace are a private-equity backed global design, strategy and construction business specialising in office fit-out, based in London. They have over 49 studios showcasing their work worldwide and emplov approximately 1,000 people.

### About Unispace Unispace's challenge

Unispace were taken over by new investors in 2021 and since then had rapidly wanted to strengthen their leadership team to support their ambitious growth plans. They needed a hands-on Director who could build relationships with the investors, improve the financial controls, governance and processes, and provide more insightful management information.

They needed a Global Finance Director to take responsibility for their Central finance team, and also had a divisional Head of Finance going on maternity leave, so they needed support quite urgently. Unfortunately, the original consultant on the job had emigrated overseas shortly after commencing the search, so our specialist consultant with 9 years' worth of networking in the construction and property sector, was parachuted in to rescue the operation.

The successful candidates have now been onboarded and plans to continue to expand the Global FD's management team by recruiting a Head of FP&A and Group Financial Controller to report into him, are underway.
